Updating Regulations that have not been updated since 1982

Regulations updated to meet federal requirements pertaining foster homes:

- Family First Prevention Services Act
- CMS Final Rule
- Prudent Parenting

Regulations were drafted in consultation with community partners, Child Placement Agencies, KFAN, Children's Alliance, DOC, KDADS, KDHE, and DCF.

A State comparative analysis was completed from other states for Child Placement Agency (CPA) included but were not limited to: Iowa, Missouri, Nebraska, North Dakota, Oregon, Texas and Oklahoma.

The regulations were drafted to meet federal requirements for FFPSA, CMS Final Rule, Prudent Parenting Standard. Once drafted, the regulations were sent to the above mentioned stakeholders for review and input. This exchange occurred on three occasions. From 2018-2019 an in-person review of the draft regulations was completed with the above stakeholders were invited.

Interest in these regulations have been expressed by Child Placement Agencies, Children's Alliance, Kansas Foster Adoptive Family Network, and Foster Parents.

These CPA regulations are being updated as they are 42 years old and are moving to DCF agency number(s). Changes in regulations align with federal requirements of FFPSA, CMS Final Rule and Prudent Parenting Standards.
