Regulations updated to Agency number: 30-47

Regulations updated to meet federal requirements:

- Family First Prevention Services Act
- CMS Final Rule
- Prudent Parenting



Regulations were drafted in consultation with community partners, Child Placement Agencies, KFAN, Children's Alliance, DOC, DCF, KDADS, KDHE

A State comparative analysis for Family Foster Home requirements was completed from other states for Family Foster Home Regulations, those states included but were not limited to: Iowa, Missouri, Nebraska, North Dakota, Oregon, Texas, and Oklahoma.

The regulations were drafted to meet federal requirements for FFPSA, CMS Final Rule, Prudent Parenting Standard. Once drafted, regulations were sent to the above mentioned stakeholders for review and input. This exchange occurred on three occasions. From 2018-2019 an in-person review of the draft regulations was completed with the stakeholder group.

Interest in these regulations have been expressed by Child Placement Agencies, Children's Alliance, Kansas Foster Adoptive Family Network, and foster parents.

Direct support of these regulations has been displayed(?) by foster parents and Child Placement Agencies.

FFH regulations are being updated to align with FFPSA, CMS Final Rule and Prudent Parenting Standards.
